Customer accepts the obligation and responsibility for all purchases made on fuel access cards assigned to this account.

I, hereby understand that purchases made at Retail Service Stations do not restrict by fuel type. I understand that I can authorize Retail Service Station fuel purchases or disallow Retail Service Station fuel purchases as indicated on the Card Set-up Information Sheet.

If fuel access card is lost or stolen, customer must notify our office immediately. Report lost cards to: (800) 464-8463 or (209) 537-0723 (24 hr access).

There is no fee for locking out a card.

Customer agrees to observe all posted safety regulations and familiarize and train all personnel using cardlock equipment of safety procedures we provide.

This cardlock contract supercedes the cardlock purchase terms on your Account Opening Agreement and Cardlock Contract with E R Vine & Sons.

## **PAYMENT AND BILLING**

Your cardlock purchases will be invoiced semi-monthly (twice a month). Billing cycle cutoffs will be the 15<sup>th</sup> and the last day of each month accordingly. Both cardlock invoices and E R Vine wholesale invoices, and your payment activity will show on your E R Vine monthly statement.

## **CREDIT TERMS**

Invoices are due and payable upon receipt. Past due if not received by 10<sup>th</sup> day from date of invoice. A service charge of 1 ½% per month, 18% per annum on all past due accounts will be assessed. Customer agrees to pay all attorney fees or collection charges associated with the collection of any past due account.

## **ACCOUNT OPENING FEES**

A \$25.00 one time, non-refundable credit search and account set-up fee will be required at time of opening the account. There are no annual fees.

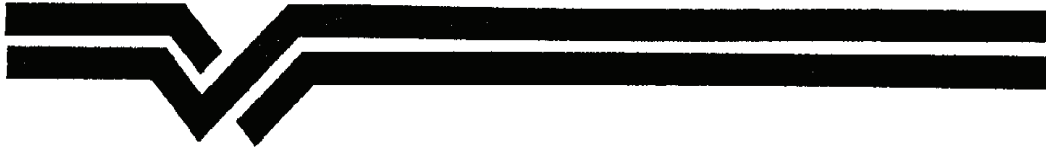
